## **Functionality / Properties**

#### Operating mode

Connect power supply to wire 1+2 and a reference signal Y to wire 3 in range of (0)2...10 VDC, actuator drives to its specified position while the pre-tensioned spring is wound up the same time. The actual damper position (0...100%) is a feedback signal U on wire 4 for example

to share with other actuators. If the power supply is interrupt, actuator drives back to position 0 by spring power. The actuator is still maintaining the minimum torque at the damper spindle.

The actuator is overload-proof, requires no limit switches and automatically stops when the end stop is reached.

#### **Direct mounting**

Simple direct mounting on the damper shaft with a clamp, protection against rotating with enclosed anti-rotation lock or rather at intended attachment points.

#### Manual override


The actuator can only be operated manually while the power supply is off. The supplied lever is used to open and lock the damper position. The lock stays until the power supply is switched on again.

#### Mode switch

DIP switch under the case cover


#### Adaption drive

- Actuator power off
- Setting the mechanical end stops
- · Actuator power on
- Adaption enable
- Actuator drive to position 0
- Actuator drive to position 1
- Adaption disable, if desired angular range reached or rather if actuator reached endstop
- "Y" refers to the measured angular range





## **Connector / Security Note**



#### Safety remarks

- Connect via safety isolation transformer!
- The device is not allowed to be used outside the specified field of application, especially in airplanes.
- It may only be installed by suitably trained personnel. Any legal regulations or regulations issued by authorities must be observed during assembly.
- The device may only be opened at the manufacturer's site.
- Cables must not be removed from the device.
- The cable of this actuator cannot be replaced. If the cable is damaged, the actuator should be scrapped.
- The device is not allowed to be disposed of as household refuse. All locally valid regulations and requirements must be observed.
- When calculating the required torque, the specifications supplied by the damper manufacturer's (crosssection, design, installation site), and the air flow conditions must be observed.
